This is a case challenging a county ordinance and its application to city-owned water utilities as exceeding the county's statutory authority and encroaching upon the city's exclusive jurisdiction. Appellants, City of Stanford, Kentucky, acting through the Stanford Water and Sewer Commission; City of Hustonville, Kentucky; and City of Crab Orchard, Kentucky, each a home-rule city, appeal from the Lincoln Circuit Court judgment upholding an ordinance enacted by Appellee, Lincoln County, which alters municipally-owned water utilities to commit city resources to a county endeavor and act as county collection agents of county fees.
