DR GRANT FROM 3 CIRCUIT COURT OPINIONS AFFIRMING DISTRICT COURT DENIALS IN FORCIBLE DETAINER CASES.

ASHLAND LEASED 24 PROPERTIES FROM SUPERASH AT RATES WELL BELOW MARKET RATE. THOSE LEASES CONTAINED RENEWAL PROVISIONS THAT REQUIRED NOTICE OF INTENT TO RENEW 120 DAYS BEFORE THE LEASES ENDED. ASHLAND FAILED TO FILE THE REQUIRED NOTICES. SUPERASH DESIRED LEASES AT MARKET RATE, AND THE PARTIES UNSUCCESSFULLY ATTEMPTED TO NEGOTIATE LEASE EXTENSIONS. SUPERASH THEN FILED FORCIBLE DETAINER ACTIONS. SIMILIAR ACTIONS WERE HELD IN OHIO PRIOR TO THE INSTANT CASES, AND OHIO APPLIED AN "HONEST MISTAKE" RULE GRANTING ASHLAND EQUITABLE RELIEF.

FAYETTE DISTRICT COURT GRANTED SJ TO ASHLAND FOLLOWING THE OHIO "HONEST MISTAKE" RULE, AND JEFFERSON AND HARRISON COURTS FOLLOWED SUIT.

FAYETTE CIRCUIT AFFIRMED ON EQUITABLE RELIEF GROUNDS. JEFFERSON STAYED ITS PROCEEDINGS WAITING ON FAYETTE, THEN ENTERED AN ORDER FOLLOWING FAYETTE BASED ON CLAIM AND ISSUE PRECLUSION THAT IT RAISED SUA SPONTE. HARRISON INVOKED THE HONEST-MISTAKE DOCTRINE AND FAYETTE'S "SPECIAL CIRCUMSTANCES" CLAIM.

SUPERASH SAYS STRICT COMPLIANCE WITH CONTRACTS IS REQUIRED, SO NO EQUITABLE RELIEF. AND IF EQUITABLE RELIEF IS AVAILABLE, A DISTRICT COURT CANNOT GRANT THAT IN A FORCIBLE-DETAINER PROCEEDING DUE TO ITS LIMITING JURISDICTION PROHIBITING THEM FROM BEING COURTS OF EQUITY, AND ASHLAND NEVER FILED A SEPERATE ACTION IN CIRCUIT COURT TO PURSUE EQUITABLE RELIEF.

ASHLAND AND SPEEDWAY DISAGREE AND RAISE VARIOUS ADDITIONAL DEFENSES TO SUBSTANTIVE CLAIM.
