2017CA000884

A child drowned in a hotel pool. The jury returned a verdict apportioning fault 65% to the child's estate and 35% to the hotel. The jury awarded \$3,000,000 in punitive damages and the trial court granted remittitur and reduced the punitive damages to \$1,058,851.25. Appellant claims the reduction of damages on remittitur appears to be an issue of first impression in Kentucky.
