KATRINA L. WILLIS v NICOLE M. FORD

This appeal is from a wrongful death trial, where the court granted constitutional standing to the personal representative pursuant to Kentucky Constitution §§ 112(5) and 241, after she was removed for cause by the probate court, for a period of 190 days during the litigation, then re-appointed *non pro tunc* in probate court. The court also erred by giving a jury instruction for pain and suffering that misrepresented the law by omitting the requirement that the jury must find from the evidence that the victim was conscious for a period of time.
