The deceased Cole and Fields, by and through their estates, allege they were residents of the state of Kentucky at the time of their death, and that the court's determination that Indiana was the most convenient forum to litigate does justify a dismissal with prejudice because none of the merits were decided by the trial court. The deceased and their children were at the time residence in Louisville, Kentucky. Thereafter they drove to the Mall at St. Matthews and from there they drove to the Walmart parking lot in Clarksville, Indiana to meet Aaron Dunn.

While driving in Indiana, they were struck by the defendant's vehicle which was traveling in the wrong direction on the interstate causing their deaths. The estate alleges that the proper forum would be the residence of the plaintiffs in the state of Kentucky.
